25 PER CENT JUMP IN PUNJAB'S STUBBLE BURNING

Marginal drop in Haryana as compared to last year

Punjab has witnessed about 25 per cent jump in incidents of stubble burning, while its neighbouring state of Haryana has seen a marginal drop in farm fires so far in the paddy harvesting season.

With farmers in the agrarian states continuing to set paddy residue afire despite a ban on this practice, many have been slapped with fines and others booked for stubble burning.

However, officials of agriculture and pollution control departments are hopeful of a decrease in the number of paddy burning incidents this season.

Government agency SAFAR said the share of stubble burning from Punjab and Haryana in Delhi's pollution rose to 46 per cent on Friday.

Punjab has reported a total of 22,137 cases of stubble burning so far, with Tarn Taran district recording 2,614 incidents, an official of the Punjab Pollution Control Board said on Friday.

Ferozepur, Patiala and Sangrur reported more than 2,000 incidents each up to October 31, official said.

As per the latest data, six districts — Amritsar, Bathinda, Gurdaspur, Kapurthala, Mansa and Muktsar — reported more than 1,000 cases of stubble burning each.

Pathankot reported only two incidents of stubble burning and was the only district where the reported cases were less than ten.

Last year, the state had seen a total of 17,646 farm fire cases up to October 31, an official said. An official of the Punjab Agriculture Department ascribed the rise in number of these cases to early maturity of crop as crop sowing was advanced to June 13 from June 20. Haryana has witnessed 4,288 cases of stubble burning, a bit lower than what it had seen last year, official of Haryana Pollution control board said here.

There were a total of 4,589 cases of stubble burning in the state up to October 31, 2018, the official said. A total of 324 complaints have been lodged with the police against farmers for stubble burning, an official of Haryana Agriculture Department said.

The problem of stubble burning was

severe in Fatehabad, Sirsa and Kurukshetra.

In Punjab, a fine of ₹43 lakh was imposed on farmers for defying the ban on stubble burning and fine of ₹52 lakh was levied on 26 combine harvester operators for not installing super straw management system (SMS).

The super SMS, which is attached to the combine harvester, cuts paddy straw into small pieces and spreads it on the field. As a result, farmers are not required to burn the straw before the sowing of the next crop.

Every year, Punjab and Haryana are blamed for the rising air pollution and smog due to stubble burning by farmers. Punjab alone generates 20 million tonne of paddy stubble annually. Delhi Chief Minister Arvind Kejriwal has blamed stubble-burning in Punjab and Haryana for the air pollution.

With farmers being encouraged to opt for farm mechanization to check stubble burning, farmers' outbursts in Punjab have been demanding Rs 100 per quintal on paddy for the management of crop residue.

two conditions but asked that Pakistan "apply this not just to Sikhs but all citizens of secular India." Also urged Pak PM to waive off \$20 fee on all days instead of just two, Capt Singh said in a tweet. India has all along been opposing the \$20 service fee that Pakistan had decided to impose on each pilgrim, and later called it a "matter of disappointment" that Islamabad hadn't heeded the request. The Kartarpur corridor connects the Dera Baba Nanak shrine in India's Punjab with Darbar Sahib at Kartarpur, just four kilometres from the international border, located at Narowal district of Pakistan's Punjab province.

Punjab presses Centre for prompt liquidation of foodstocks under open market sale scheme

CM to meet
Modi, Paswan to resolve storage & enhancement of PDS allocation issues

Taking note of the prevailing storage space crunch, Punjab Chief Minister Capt Amarinder Singh on Friday urged the Central Government to allow quick liquidation of

food stocks through its Open Market Sale Scheme (OMSS) to address the problem.

The Chief Minister said that he would soon meet the Union Food Minister Ram Vilas Paswan to seek his personal intervention to get the storage issue resolved. "And if need be, I would also take up the issue with Prime Minister Narendra Modi," he said.

Capt Amarinder, chairing a high-level meeting to review the ongoing paddy procurement operations in the state, directed the Principal Secretary (Food and Civil Supplies) KAP Sinha to ask Food Corporation of India (FCI) to submit storage-gap analysis at the earliest to enable the State to chalk out a comprehensive action plan in case the Centre fails to lift the committed storage stocks.

He said that he would also raise with the Central Government the issue of enhancing state's PDS allocation quota in order to dispose of additional quantity of stored foodgrain, which would in turn help the state in easing out the pressure on storage capacity.

"The state, at present, is short of 40 lakh MTs space, considering the current pace of evacuation, which in the wake

of a bumper Kharif crop has put further pressure on the existing storage space," he said.

Responding to a proposal put forth by Mandi Board chairman Lal Singh, the Chief Minister consented to utilise the space for storage of food-grain across 93 mandis sheds, as identified by the Board.

He asked the managing directors of Punjab State Warehousing Corporation (PSWC) and MARKFED to prepare a blueprint for creation of warehousing infrastructure.

Expressing concern over the Centre's move to shift from the MSP regime, Capt Amarinder warned that any proposal to tweak this time-tested mechanism should be meticulously studied and planned before its implementation, so as to safeguard the interests of the farming community.

Capt Amarinder, expressing satisfaction over the swift pace of procurement in the state, lauded the efforts of the Food Department in ensuring hassle-free and smooth procurement and lifting, as well as timely payments to the farmers.

Meanwhile, the Principal Secretary Food disclosed that against the targeted procurement of 170 Lakh MTs, nearly 108.50 Lakh MTs of paddy had already been procured till date during the ongoing Kharif Marketing Season. He hoped that the entire procurement operations would be completed by November 30 well, well before the cut-off date of December 15.
