Farmers to decide whether to talk with Akalis

The Samyukta Kisan Morcha (SKM) — a pan-India umbrella body heading the farmers' protests against the Centre's three contentious agrarian laws — will take the final call on the Shiromani Akali Dal's (SAD) request to hold talks with its leadership to clear any doubts or misgivings regarding party's 'Gal Punjab Di' campaign.

The SKM will hold its meeting on September 8 (Wednesday) where the SAD's letter will be discussed thread-bare and decision on the same would be taken.

Notably, the clashes broke outside SAD president Sukhbir Singh Badals rally venue in Moga between the farmers and the police, leaving over 60 farmers and nearly about half a dozen cops severely injured. Taking serious note, the Akali Dal announced to postpone its 'Gal Punjab Di' campaign for a week. With assembly elections just about six months away in Punjab and SAD's poll campaign hit a roadblock due to farmers' protest, the Akali Dal on Monday went ahead to

invite the all the 32 farmer organizations of Punjab as well as the Bhartiya Kisan Union (BKU), Ekta-Ugrahan, headed by Joginder Singh Ugrahan to constitute a committee to hold talks with the party to remove all misgivings regarding the campaign. Responding, the state's farmers' leaders maintained that they would go by the SKM's decision.

BKU (Lakhowal) state convener Harinder Singh Lakhowal said that the SAD's letter will be placed before the SKM in its meeting on September 8 and will respond to its demand after holding a detailed discussion on that.

"As it's a sensitive issue, we can't hurt sentiments of the people. We will discuss about it from every perspective on September 8 in SKM's meeting," said BKU Kadian's national spokesperson Ravneet Brar.

The state farm leaders also indicate that along with Akali Dal, they may also take on board other political outfits like the Congress, the Aam Aadmi Party (AAP) in the wake of the ensuing polls in the state, scheduled to be held early next year.

"It is our democratic right

to question all parties, whom are voting for and electing. It is our right to ask them for their promises and what all they have done for us...regarding what is their roadmap for us... It is our right to question them," said Lakhowal.

SAD APPROACHES PUNJAB'S 32 FARMER ORGS, UGRAHAN GROUP FOR FORMAL TALKS

SAD on Monday written a letter to Punjab's all 32 farmer organizations as well as the BKU (Ekta) headed by Joginder Singh Ugrahan to form a panel to hold talks with it "to remove all misgivings regarding the Gal Punjab Di campaign."

SAD's senior leader and former MP Prem Singh Chandumajra, in his letter, said that Akali Dal had always stood up the cause of farmers and supported every decision of the Samyukat Kisan Morcha (SKM).

"It is with this spirit and the welfare of farmers that we wish to engage with farmer organizations and address all their concerns as well as work unitedly to ensure the repeal of the three black laws. This is also

why we have postponed our campaign for one week," said Chandumajra adding that on SAD's part, senior leaders including Balvinder Bhundur and Manjinder Singh Sirsa would engage with the Kisan organizations "at the time and place of their choice".

Chandumajra explained how the SAD had exercised its democratic right to reach out to the people through the Gal Punjab Di campaign and take feedback on steps needed to rebuild the State which had been devastated during Congress misrule. "I'm sure the Kisan organizations will understand this sentiment and realize that we are working for the welfare of farmers and people of the State at large," he said.

SAD leader said that the Congress party in Punjab was a divided house and its Government and Chief Minister Capt Amarinder Singh had failed to deliver on any of the promises made to the people.

"All sections of society are suffering be it farmers, youth or the weaker sections. There is no rule of law in the State and gangster culture is on the rise," he said.

He said that similarly AAP convener and Delhi Chief Minister Arvind Kejriwal had always worked against the interests of Punjab be it adopting double standards on the SYL issue in Punjab and Delhi, demanding action against farmers of Punjab for burning stubble and calling for closure of the thermal plants of the State in the Supreme Court.

Chandumajra said that in such a situation, SAD was the only hope for the people of Punjab and that was why people were turning out in huge numbers to attend the recent party programmes. "This apparently is not being liked by the Congress and AAP parties who want to defame farmers as well as their sacred cause by vitiating the peace of the State. These parties are also falling prey to the Central Government policy to spoil the atmosphere in the State and create conditions for imposition of the President's Rule," he said.

SAD leader said that in such a situation, it was necessary to clear all doubts in the mind of the farmer organizations vis-a-vis the party pro-

grammes of the SAD. "We are hopeful the farm leaders will react positively to the process of dialogue and the entire issue will be resolved to everyone's satisfaction," said Chandumajra.

MAJITHIA ASKS ALL PARTIES TO COME TOGETHER FOR FARMERS' CAUSE

SAD MLA and former Minister Bikram Majithia on Monday said that the leaders, cutting across political lines, should come under the same banner to fight for the cause of farmers, who have been staging protests at the Delhi borders since November 26, 2019, seeking the repeal of the three farm laws. Majithia said that the huge turnout at the Kisan Mahapanchayat was the testimony to the fact that the farmers were ready for a long haul and would not end their agitation till the 'black' farm laws were repealed.

"The farmers' movement, which has been going on for nine months for its existence, has demonstrated the strength of communal harmony and unity," he said.

Punjab CM slams Leader of Opposition on law & order, claims State No 1 in country for best performance

Taking the Leader of Opposition in Punjab Vidhan Sabha Harpal Singh Cheema to task over his "misleading" and "politically-motivated" statement on the State's law and order situation, Chief Minister Capt Amarinder Singh on Monday slammed the Aam Aadmi Party (AAP) for mutilating facts in a desperate bid to win 2022 electoral battle, which they can already see slipping away from their hands.

Responding to AAP MLA Cheema's "unfounded and baseless" allegations of increasing cases of crime in the State, the Chief Minister expressed shock over Leader of Opposition's "highly irresponsible behaviour" in spreading

false information based on some unsubstantiated media report.

"Instead of picking up unverified data from here and there, Cheema could have approached the DGP to get the facts, which are completely removed from what he has put in his press release," said Capt Amarinder.

Cheema has once again proved that AAP's ideology is based on lies and fabrications, with all the leaders of Arvind Kejriwal's party having become masters of deceit, quipped the Chief Minister, adding that contrary to Cheema's claims, only 38 cases of 'kidnapping for ransom' have been reported in the State since his Government took over in March 2017.

Even those meagre 38 cases

(0.5 percent) relating to 'kidnapping for ransom', registered since March 2017, were solved with the victim's release successfully secured and culprits arrested in each of them, said the Chief Minister, adding that even convictions have been obtained in many instances by fast tracking of criminal trials in serious cases.

"This is a far cry from 7,138 incidents cited by Cheema, who evidently cannot differentiate between kidnapping for ransom and other cases of abduction or kidnapping. But then, given your total lack of experience of governance or administration or policing, this does not come as a surprise," remarked the Chief Minister, taking a dig at Cheema.

"In many such cases, at the time of the filing of the FIRs, the family is initially not even aware of the cause of their disappearance and therefore files a report of kidnapping or abduction, which Cheema neither knows nor has bothered to find out," he quipped.
