

Particulars of an order of a court, tribunal, or arbitral panel adjudicating on default, in any (attach a copy of the order) The financial creditor had filed a petition under Section 7 of IBC, 2016 for initiation of CIRP against the Corporate Debtor and the same was admitted by the Hon'ble NCLT, Chandigarh Bench vide order dated 16.04.2024.

Although the said order was challenged by the CD before the Hon'ble NCLT, New Delhi and the operation of the admission order dated 16.04.2024 has been stayed during pendency of the appeal by the Hon'ble Appellate Tribunal vide order dated 24.04.2024. The appeal is pending adjudication before the Hon'ble NCLT, New Delhi.

Further, the financial creditor has filed an Original Application under Section 19 of the Recovery of Debts and Bankruptcy Act, 1993 before the Hon'ble Debt Recovery Tribunal Chandigarh and the same is pending adjudication.
